Tiger Fan heaters – sockets

We have expanded the product range of Tiger Fan Heaters equipped with 230V outlets (sockets). The reason is that different markets requests different sockets, type E or F.

P33, P53 and P93 with type E sockets have been re-named to **P33B**, **P53B** and **P93B**. The reason for this change of name is that these products have been re-classified to LPR-products for specific markets. The construction of the products has not changed.

Our new **P33**, **P53** and **P93** are equipped with type F sockets. These products are classified as our BPR-range. Please note their new article numbers.

For **P3323** and **P5323** (230V3~), products with type E sockets will be sold out and thereafter replaced with type F sockets.

The catalogue pages and manual will soon be updated accordingly.
